The Legal Decree n.º 64/2006, 21st march regulates the specially adequate examinations destined to evaluate if the over 23 years old candidates have the conditions to attend the higher education level. This legislation replaces the previous regime of ad-hoc exams, by an assessment system of the exclusive responsibility of the higher education institutions, with the aim of boosting the opportunity for adults in active life to access higher education levels, thus promoting equality of opportunity in the access of this degree of education. It is up to each higher education institution to define which forms/exams are adequate for each course and candidate, to assess the ability to attend a bachelor's degree program.

Candidates who can apply must be over 23 years old or must have turned 23 years old until the 31st of December of the year before the exams, if they meet all the following requirements:

- a) Not having the qualification to access the intended course. Access qualification means:
 - I. high school degree or equivalent;
 - II. National exams approval required for admission to the course.

2. Application submissions

From July 4th to July 24th, 2023

The application is submitted online, through the Academic Services' contact form of NOVA IMS <https://onlinev2.novaims.unl.pt/contacto/> where you should upload the documentation requested in point 3.

Payment of the application fee (70 Euros). This amount must be paid:

Only in case of admission will it be necessary to deliver/present the original documents mentioned in point 3.

Weight in the final classification – 20%
- Motivation letter
Weight in the final classification – 10%
- Qualification certificate;
- Statement, under oath, that the candidate does not have a higher educational qualification;

4. Written Mathematic A exam (minimum grade 9,5) – 10:00am – July 26th 2023:

Weight on the final classification – 50%

5. Interviews with Course Coordinators – 28th and/or July 31st 2023

Weight on the final classification – 20%

6. Decision and publication of the public notice with the results

August 4th 2023

7. Appeal

Complaints after the decision may be sent in written form to the Academic Services of NOVA IMS and properly well-founded, within five working days, counting from August 4th 2023.

It will be the Scientific Council's responsibility to decide about the complaints, within a maximum of ten working days after receipt of the complaint, after hearing the Director of the course involved. The final decision of the Scientific Council cannot be contested.
